
A. WELCOME AND CONFIRMATION OF MINUTES

		It is further informed that NIT Delhi is one of the New 11 NITs and the original DPR was prepared on the basis of 1260 students at par with all other NITs including North-East Region. NIT Delhi has in its possession 51.4 acres of land and institute is ready to begin phase-wise construction of the Permanent Campus. Keeping in view the population density and demand from the region i.e. NCR and UT Chandigarh, an upward revision of DPR from 1260 to 2800 students is justified, so that the construction activities could be planned in two to three phases and Govt. of India may provide funds as per revised DPR. The Hon'ble Members of FC considered the proposal and Hon'ble Chairman was agreed for taking up the matter with the Hon'ble Minister of HRD. The Hon'ble Members of the FC also advised to discuss with NBCC to suggest alternatives regarding Foundation Work in one go and implement construction activities in phased manner as per DPR.
